## **A look back...**

It's 1981, Ronald Reagan is sworn in as the 40<sup>th</sup> POTUS. Minutes later, Iran releases the 52 American hostages that were held for 444 days. ## History of the Corvette, part 28

The 1981 Corvette was the last model to come out of the St. Louis plant and the first to roll off the Bowling Green, Ky assembly lines. The combined output of the two plants totaled 40,606 units.

Production at the new Bowling Green facility (recently purchased from Chrysler) began on June 1<sup>st</sup> while the St Louis plant ceased Corvette production on August 1<sup>st</sup>. The move to the newer, more modern Bowling Green facility promised to finally get the fit and finish problems under control. A major improvement would be the change in the paint systems employed. Gone were the lacquer finishes of St Louis, being replaced with enamel color coats followed by a clear top coat. Now, as a result of much these better painting capabilities, buyers were offered, in addition to the single colors, the option of one of four two-toned paint schemes.

The 1980 Corvette employed a sophisticated *computer command control* (CCC) on the 305 cubic inch California engine. For 1981, this advanced CCC was adopted on all the 350 cubic inch engines as well. In addition to the CCC, the new Corvette used a stainless steel exhaust manifold, similar to the 305 cubic inch California engine. These changes allowed the 350 cubic inch engine to now meet the California requirements. With the latest version of the CCC the engine was being tuned continuously for optimal emissions with fuel efficiency an afterthought.

The only engine offered in 1981 was the 190 HP 350 V8 with no available power options. Other than the CCC, the only other significant improvement was the use of a fiberglass reinforced leaf spring in the rear suspension, which reduced the car's weight by 36 pounds.

Interior changes included a now standard quartz clock, an electronically tuned radio and a 6 way power seat for the driver, which now reclined.

The move to Bowling Green (and the shutting down of the St Louis line) and model wide adoption of the new CCC may have had some impact on the sales price. The sticker rose to \$16,258, which was more than a new Cadillac El Dorado.

# COVID 19

I have become aware of the following direction from NCCC concerning any event that we may be having in regards to protecting the club from any liability concerning COVID 19. This will pertain to our upcoming Caravan and Picnic. Everyone will be receiving updated information before the events. This is from Jim Walton NCCC Business manager;

*NCCC coverage concerning Covid 19:*

*Sickness and Disease are covered in the NCCC Policy the same way as any other 3<sup>rd</sup> party bodily injury claim. So NCCC is covered for any Covid 19 claims made by a 3<sup>rd</sup> party. There is also Directors and Officers insurance in case you as an officer get sued directly.*

*What has changed is how we base the use of our waivers on the risk associated with the event. So now with the virus otherwise low risk activities, such as a club meeting, now have a higher risk. So NCCC has to rethink when and what types of events should require a waiver. The use of waivers is the primary defense against NCCC getting sued by a member.*

***It is mandatory that every club gathering or activity have everyone sign the standard waiver until the Covid threat has passed***, even those activities which did not previously require waivers noted in FAQ's. Currently we are working with Legacy Insurance on a new waiver form that would include Covid Language. NCCC has begun to look at electronic waivers and how we might be able to use them in our organization, but for now let's keep using the paper waivers. Electronic waivers will have to meet our insurance requirements as well as the Competition Manual.

***Any announcement of an activity, such as a flyer, should include that attendance is voluntary and at your own risk.*** Also, state that individuals are responsible to maintain their own social distancing and if they are sick not to attend. Hand sanitizer should be available to members after contact activities should as signing the waiver. Please use the Covid comprehensive precautions that were published by the Competition Committee for your events.

***It is very important any event follows all state and local regulations.*** Not being in compliance could make your event illegal and put your coverage into question. Use common sense in laying out your event to limit member to member exposure.

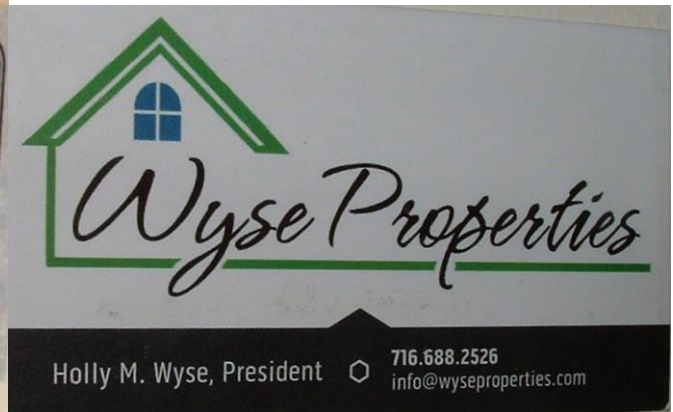
